The contest will encourage New Mexicans to show off and submit their favorite photos of sunshine in our state. Whether it's a sunrise over White Sands, an afternoon hike at Tent Rocks, or even their pet basking in the warmth of the sun.

PARTICIPATING IN THE CONTEST

New Mexicans will post photos to Facebook, Instagram or twitter and tag them with #ShareYourSunshine in the photo caption to enter the contest, beginning at 12:00 a.m. on Sunday, March 15, 2015, through 11:59 p.m. on Saturday, March 21, 2015. The FOG staff and board of directors will vote to select their favorite photos and notify winners. The first-place winning entry will receive \$100, second place \$50 and third place \$25.





OFFICIAL #SHAREYOURSUNSHINE CONTEST RULES

- Photos must have been taken in New Mexico
- Photographs must be a minimum 300 dpi resolution.
- Each contestant may enter no more than 5 photos per day of the contest, of a maximum of 35 total entries.
- By submitting photos, you give the New Mexico Foundation for Open Government permission to use them. The permission includes, but is not limited to, publication in printed materials, web sites and internal communications. You will not be compensated for such use. However, where reasonable, we will give you credit for the photos.
- The NMFOG staff and Board of Directors will select one first-place winning entry, one secondplace winning entry and one third-place winning entry. Winner shall be notified on the social media account and email addresses used to enter the contest.
- Current NMFOG staff, board and immediate family members may not participate.
- The New Mexico Foundation for Open Government reserves the right to amend all photo contest rules.

PLEASE DO NOT ENTER PHOTOS THAT:

- You did not take or that are copyrighted by someone else.
- · Are less than 300dpi in resolution.
- Show nudity, drugs, violence or symbols or acts of hatred.
- Include a watermark or photographer logo.
- Are illegal or prohibited. We reserve the right to disgualify photos.

PHOTO CONTEST FAQs

How do I enter?

Anyone over the age of 18, or minors who can supply written consent by a parent or guardian if their photo is selected as a winner.

When can I enter?

Photos will be accepted for consideration from 12:00 a.m. on Sunday, March 15 through 11:59 p.m. on Saturday, March 21, 2015.
