COMPLAINT FOR ENFORCEMENT OF PROVISIONS OF THE INSPECTION OF PUBLIC RECORDS ACT

COMES NOW the Plaintiff and makes the following Complaint regarding enforcement of provision of the Inspection of Public Records Act pursuant to NMSA §14-2-11;

- 1. The Plaintiff is a resident of Rio Arriba County.
- 2. The Defendant is the Clerk of Rio Arriba County.
- 3. The Plaintiff made requests under the NMSA §14-2-1 for inspection of public records in the possession of Rio Arriba County.
- 4. All requests were made to the Clerk of Rio Arriba County.
- All relevant actions took place within Rio Arriba County and were with the Clerk or her employees, all of whom work in Rio Arriba County.
- 6. Venue is proper in Rio Arriba County.
- 7. On July 22, 2020 the Plaintiff submitted a written request for the surveillance video taken in the Rio Arriba County Adult Detention Facility on December 7 and 8 of 2018 showing a specifically described area and event (Exhibit 1).
- 8. This request was submitted by email to public.requests@rio-arriba.org.

9. Receipt of this request was acknowledged by the Defendant through letter dated July 22,

2020 (Exhibit 2).

10. More than fifteen days has elapsed since the request was made, and no response has been

provided.

11. A written request for inspection of public records that has not been permitted within

fifteen day of receipt by the office of the custodian may be deemed denied pursuant to

NMSA §14-2-11A.

12. No written explanation of the denial of the request was ever provided the Plaintiff. Such a

written explanation is required by NMSA §14-2-11B.

13. Pursuant to NMSA §14-2-11 C Plaintiff may maintain this action for enforcement of the

provisions of the Inspection of Public Records Act.

WHEREFORE, Plaintiff requests that:

A. The Defendant be required to permit the inspection of the records that were requested;

B. Award damages pursuant to NMSA §14-2-11C (1)(2)(3)(4);

C. Award court costs;

D. And, any other relief deemed appropriate and available by law.


