### COMPLAINT FOR DECLARATORY JUDGMENT ORDERING PRODUCTION OF CERTAIN RECORDS AND INFORMATION

COMES NOW, Plaintiff Aubrey L. Dunn, through undersigned counsel, and states the following:

#### GENERAL ALLEGATIONS

1. Plaintiff Aubrey L. Dunn is a resident of Torrance County, New Mexico.

2. Defendant New Mexico Department of Game and Fish (NMDGF) is the hunting

and fishing regulation agency for the State of New Mexico.

3. This action is brought by Plaintiff, a resident of Torrance County, New Mexico against the New Mexico Department of Game and Fish to enforce the provisions of the New

Mexico Inspection of Public Records Act, NMSA 1978 § 14-2-1 ("IPRA").

4. The IPRA provides that, with only certain, specified limitations, "Every person has a right to inspect public records of the state." *Id.* 

5. By email dated January 3, 2017, (See Exhibit A – Email Request) Plaintiff through counsel requested the opportunity to inspect, examine, or be provided the list of names with email addresses for the hunters currently on file that applied in 2015 and 2016.

6. By email dated January 4, 2017, Defendant's response to the request was that the Department would be redacting the personal identifiers, which would include the requested email addresses. (Exhibit B – Email Response)

7. By email dated January 4, 2017, Plaintiff through counsel requested a formal denial with explanation of the exception. (Exhibit B)

8. January 9, 2017, Defendant responded with a formal letter. (Exhibit C)

9. This letter from the Records Custodian of Defendant stated that the request is not denied, but the contact information requested would not be provided as the New Mexico Department of Game and Fish does not believe it to be a public record, and that the file would be closed.

10. NMDGF has provided no citation or basis for this denial. Email addresses when collected by a state agency are in fact public records.

#### COUNT I

#### VIOLATION OF THE NEW MEXICO INSPECTION OF PUBLIC RECORDS ACT

11. Plaintiff incorporates by reference the claims, facts, and allegations set forth in the above paragraphs.

12. Pursuant to NMSA 1978 § 14-2-1 Defendant has violated the New Mexico Inspection of Public Records Act by failing to provide the requested public records.

13. Because Defendants have violated the IPRA by failing to produce to Plaintiff the public records requested by Plaintiff without justification under the law, Plaintiff is entitled to an injunction ordering the Defendants to produce all relevant documents in the Defendants possession.

WHEREFORE, Plaintiff respectfully requests that this Court exercise its jurisdiction and enter, pursuant to this Court's original jurisdiction, and the New Mexico Inspection of Public Records Act:

- A. A declaratory judgment adjudicating that the denial of the public records requestd by Plaintiff is in violation of the New Mexico Inspection of Public Records Act, or if necessary, a writ of mandamus requiring the Defendants to produce the requested records;
- B. Judgment in favor of Plaintiff on Defendant's violation of the Inspection of Public Records Act;
- C. An injunction to enforce the provisions of the New Mexico Inspection of Public Records Act;
- D. An Order awarding Plaintiff statutory damages for violation of the Inspection of Public Records Act;
- E. An Order awarding Plaintiff his costs and reasonable attorneys' fees as provided by law;
- F. Such other and further relief as the Court deems just.
