## AMENDED VERIFIED PETITION FOR A WRIT OF MANDAMUS

COMES NOW, Petitioner, Gordon Mast, Pro Se with this Amended Verified Petition for a Writ of Mandamus pursuant to NMSA 1978 § NMSA1978 sec. 14-2-1(Inspection of public records act) A ,"Every person has a right to inspect public records of this state". and NMSA 14-2-11 (C)"A custodian who does not deliver or mail a written explanation of denial within fifteen days after receipt of a written request for inspection is subject to an action to enforce the provisions of the Inspection of Public Records Act and the requester may be awarded damages."

## Petitioner alleges:

- 1. Petitioner is a resident of Luna County, New Mexico.
- 2. Respondent is the present Luna County Magistrate Court Clerk. located at 912 South Silver, Deming, New Mexico 88030.
- 3. Venue is proper in this Court. NMSA 44-2-3.. The district court has exclusive original jurisdiction in all cases of mandamus, and NMSA1978 sec. 38-3-1 (G). "Suits against any state officers as such shall be brought in the court of the county in which their offices are located,

- 4. Petitioner mailed a written request for public records on February 8, 2010
- 5. Petitioner mailed follow up requests on March 17, 2010 and again on May 10, 2010.(see Exhibits #1,#2, &#3 (attached)
- 6 Respondent ignored all requests by Plaintiff.
- 7. RESPONDENT has failed in her mandatory and non-discretionary duty to comply with

NMSA1978 sec. 14-2-8 (D). "A custodian receiving a written request shall permit the inspection immediately or as soon as is practicable under the circumstances, but not later than fifteen days after receiving a written request. If the inspection is not permitted within three business days, the custodian shall explain in writing when the records will be available for inspection or when the public body will respond to the request. The three-day period shall not begin until the written request is delivered to the office of the custodian."

- 8. Petitioner is a person "beneficially interested" in the issues of this case, namely the lack of "sense of duty" by tax supported employees. Petitioner is also uniquely affected by the UN-constitutional conduct of the Respondent.
- 9. Petitioner has no plain, speedy and adequate remedy in the ordinary course of law.
- 10. Petitioner has a right to remedy, by law; NMSA 14-2-11 (C). "A custodian who does not deliver or mail a written explanation of denial within fifteen days after receipt of a written request for inspection is subject to an action to enforce the provisions of the Inspection of Public Records Act and the requester may be awarded damages. Damages shall":
  - (1) be awarded if the failure to provide a timely explanation of denial is determined to be unreasonable;
  - (2) not exceed one hundred dollars (\$100) per day;
  - (3) accrue from the day the public body is in noncompliance until a written denial is issued; and
  - (4) be payable from the funds of the public body.

WHEREFORE petitioner prays that he be awarded a Writ of Mandamus commanding Respondent to:
